28-12-2021 dated - Classic Cars Club

We, Sultan bin Muhammad Al Qasimi, Ruler of the Emirate of Sharjah,

Having reviewed the Constitution of the United Arab Emirates,

Federal Decree-Law No. (7) of 2008 concerning the General Authority for Youth and Sports Welfare and the entities operating therein and its amendments,

Law No. (2) of 1999 AD regarding the establishment of the Executive Council of the Emirate of Sharjah and its internal regulations and amendments,

Law No. (4) of 2018 regarding the organization of the Sharjah Sports Council,

Administrative Decision No. (1) of 2017 regarding the management of the Sharjah Classic Cars Club,

Based on the proposal of the Sharjah Sports Council and the approval of the Executive Council of the Emirate of Sharjah, and in accordance with the public interest,

We have outlined what is to come:

Article 1 Definitions

For the purposes of this decree, the following words and phrases shall have the meanings assigned to them below, unless the context otherwise requires:

Article 2 Construction

A club specializing in community-based cultural and sporting affairs for vintage car and motorcycle enthusiasts is being established in the emirate, and it is called:

Sharjah Classic Car Club

It has legal personality and full capacity to carry out the legal actions necessary to achieve its goals and exercise its powers. It is affiliated with the Sports Council and operates under its supervision.

Article 3 of the decree

The club's headquarters and main center shall be in the city of Sharjah, and it may, by decision of the Sports Council and upon the request of the President, establish branches for it in the other cities and regions of the emirate.

Article 4 Objectives

The club aims to achieve the following:

Spreading the culture of classic car and motorcycle sports and hobby, raising community awareness of its importance, .1 and promoting participation in it.

To enhance the emirate's position in the field of classic car and motorcycle sports and hobby, both domestically and .2 internationally.

Serving the sports, cultural and community sector in all aspects and developing the sport and hobby of classic cars and .3 motorcycles.

Contributing to the development of a modern and integrated system for developing the legal and administrative .4 systems related to the sport and hobby of classic cars and motorcycles in the emirate, in accordance with best practices.

Empowering national talents and providing the necessary resources to practice the sport and hobby of classic cars and .5 motorcycles.

Article 5: Powers

In order to achieve its objectives, the club shall exercise the following powers:

- Setting the general policy and developing strategic plans to organize work in the club. .1
- Training leaders and experts in the field of classic car and motorcycle sports and hobby. .2
- Representing the Emirate at the internal and external levels of the country in bodies related to the sport and hobby of .3
old cars and motorcycles, in coordination with the Sports Council.
- Preparing and implementing awareness and promotional campaigns aimed at spreading the culture of classic car and .4
motorcycle sports and hobby.
- Organizing and hosting festivals, competitions, conferences and gatherings related to classic car and motorcycle sports .5
and hobbies, and attracting participants in coordination with the Sports Council.
- Providing an opportunity for all segments of society to practice the sport and hobby of classic cars and motorcycles, in .6
order to prepare them to participate in local, regional and international competitions and exhibitions.
- Providing all the necessary capabilities and requirements to enable and encourage all segments of society to practice .7
the sport and hobby of classic cars and motorcycles, as well as cultural and community activities.
- Cooperation with various clubs and institutions inside and outside the country. .8
- Preparing and submitting recommendations and draft legislation related to the practice of classic car and motorcycle .9
sports and hobbies in the emirate to the Sports Council to take whatever action it deems appropriate regarding it.
- Proposing the revenues collected in return for the services provided by the club, in coordination with the Sports .10
Council, to be presented to the Executive Council for it to take whatever action it deems appropriate regarding them.
- Enhancing the safety of practitioners of classic car and motorcycle sports and hobbies in the emirate, in coordination .11
with the relevant authorities at the federal and local levels.
- Coordination with the relevant authorities to provide and facilitate licensing services for old cars and motorcycles. .12
- Providing inspection, maintenance and repair services for old cars and motorcycles. .13
- Implementing quality systems, corporate work requirements, and excellence standards in the club. .14
- Establishing commercial companies of all kinds, whether for sports purposes or for investments belonging to the club, .15
after approval by the Sports Council.
- Any other responsibilities assigned to the club by the governor or the executive council. .16

Article 6 Administration

The club is managed by a board of directors consisting of a president, a vice president, and a number of members .1
appointed by a decision from the governor or his representative.

The Vice President is chosen from among the members during the first meeting of the Council by consensus or by .2
direct secret ballot.

Article 7 Term of membership in the Council

The term of membership in the council shall be four years, starting from the date of the decision to form it, and it may be extended for a similar period or periods, provided that the council continues to conduct its business upon the expiry of its term until a new council is formed or the expired council is renewed.

Article 8 Conditions of Council Membership

The following conditions must be met by a member of the council:

- To be a citizen of the country. .1
- To be of legal age, of good character and reputation, and not previously convicted of a crime involving moral turpitude. .2
He had not been legally rehabilitated.
- His age must not be less than twenty-five years. .3
- He must not be a member of any other club's board of directors. .4
- His educational qualification must be at least a high school diploma or its equivalent. .5

Article 9 Loss and Termination of Council Membership

Council membership is lost or terminated in the following cases: .1

Death.

Loss of one of the membership conditions stipulated in Article No. (8) of this decree.

Written resignation and its acceptance by the sports council.

Absence from four consecutive council meetings or six separate meetings without an excuse accepted by the council during the calendar year, to be calculated from the date of the first council meeting.

If the position of a member of the Council becomes vacant for any of the reasons stated in paragraph (1) of this Article, .1 the Governor or his deputy shall appoint a replacement for him, and the new member shall complete the term of membership of his predecessor.

Article 10: Powers of the Council

Subject to relevant federal and local legislation, regulations, and bylaws, the Council directly manages the club's affairs, conducts its business, and works to achieve its objectives. It is considered the supreme authority within the club and, to that end, has the following powers:

Adopting the club's general policy and strategy, programs and projects after presenting them to the sports council, .1 supervising their implementation and developing plans that ensure the development of work in the club and its employees.

Supervising the workflow in the club in accordance with applicable legislation and regulations, issuing the necessary .2 administrative decisions and circulars, and following up on their implementation.

Develop the financial and administrative regulations, internal work systems of the club, and membership requirements, .3 and present them to the sports council.

Forming permanent or temporary committees to assist him in performing his duties, determining their names, tasks, .4 powers, work system, and supervising them.

Proposing the annual budget and approving the club's final accounts, and presenting them to the sports council for .5 appropriate action.

Representing the club in concluding contracts, agreements, memoranda of understanding and partnerships with others .6 after their approval by the Sports Council.

Opening and managing the club's financial and commercial bank accounts. .7 Appointing the CEO and technical and administrative staff. .8

He may seek assistance from whomever he deems appropriate, including technicians, experts, volunteers, and relevant .9 authorities, to help him perform his duties and achieve his goals.

Any other responsibilities assigned to him by the governor or the executive council. .10

Article 11 Council Meetings

The council shall meet at least once a month at the invitation of the president or his deputy – in the absence of the .1 president – unless the interest requires that it meet more often than that.

Council meetings are valid if more than half of the members are present, provided that the president or his deputy is .2 among them.

Council decisions are issued by a majority vote of those present. In the event of a tie, the side on which the chairman .3 of the meeting is present prevails. Council decisions are recorded in minutes signed by the chairman of the meeting and all members present.

Article 12 Responsibility of Council Members

The council member alone bears responsibility for any actions or statements he makes, regardless of their form or .1
means, if they result in any penalties or fines.

If a member of the board believes that the club's affairs are being conducted in a way that is detrimental to its .2
interests, or that the board intends to take action or refrain from taking action that would harm the club's interests, he
has the right to submit a request to the sports council, supported by documentary evidence, to issue whatever
decisions he deems appropriate in this regard.

A member of the council may not dispose of any of the club's fixed and movable property by sale, mortgage, .3
assignment or exchange except by a decision of the council and the approval of the sports council.

Article 13 Executive Director

The club shall have a full-time executive director with competence and experience in the sports and cultural field, who shall be appointed by a decision of the board after approval by the sports council. The board shall determine his powers and duties and he shall be responsible to it.

Article 14 Financial Resources

The club's financial resources consist of the following:

Government allocations. .1
The club's own revenues are a result of exercising its functions. .2
Revenue from investing club funds, marketing, and sponsorship rights. .3
Membership and subscription fees. .4
Donations, gifts and bequests approved by the Sports Council. .5
Any other resources approved by the governor or the executive council. .6

Article 15

The club follows the accounting principles and rules of the Sports Council in organizing its accounts and records. .1
The club's fiscal year begins on the first day of January and ends on the thirty-first day of December each year. .2
The sports council may review the club's financial, banking and administrative records and statements. .3

Article 16 Organizational Structure

Based on the council's proposal and the approval of the sports council, the club's organizational structure is issued by a decision of the head of the sports council.

Article 17 Final Provisions

The board is bound by the club's approved budget and may not exceed it except with the approval of the sports council. .1
The club adheres to all decisions and circulars issued by the Sports Council. .2
Based on the approval of the Sports Council, the President issues decisions, regulations, and systems relating to .3
personnel and financial affairs, and amends them in accordance with the club's objectives and competencies.
The powers of the president, vice president, members and committees of the club are determined according to the .4
regulations issued by the sports council.

The club may only spend its money on the purposes for which it was established. .5
All fixed and movable property, donations and subsidies are considered the property of the club and its members have .6
no right to dispose of them. In the event of its dissolution, all of that shall revert to the sports council.

The club's funds are considered public funds and are exempt from all local taxes and fees of all kinds, with the .7 exception of consumption taxes.

The club adheres to all rules and regulations issued by local and international sports federations related to its activities. .8

The board is committed to reviewing the club's monthly financial report at each of its regular meetings. .9

The council is not entitled to obtain financial loans from any entity without the approval of the sports council. .10

Article 18

All actions and transactions that took place before the issuance of this decree shall be considered valid as if they were issued pursuant to it.

Article 19

All rights, assets, holdings and obligations of the Sharjah Classic Cars Club shall be transferred to the club, and its employees shall be transferred to the club, with their appointment being decided by the Chairman of the Sharjah Sports Council.

Article 20

This decree shall be effective from the date of its issuance, and the concerned authorities shall implement it, each within its respective jurisdiction, and it shall be published in the Official Gazette.
